Are US exports to Peru still subject to tariffs?

As a result of the U.S.-Peru Trade Promotion Agreement (TPA), U.S. consumer and industrial goods exports to Peru are no longer subject to tariffs. For agricultural products, tariffs have been eliminated on almost 90% of U.S. exports, with remaining tariffs being phased out by 2026.

Does Peru have a reciprocal tariff?

Peru, as a country not listed in the initial Annex I for higher rates, is subject to the 10% baseline reciprocal tariff on most imports (effective since April 2025). U.S.-Peru Trade Promotion Agreement (TPA) remains in effect, but tariff benefits are partially overridden.

How will The PTPA affect US exports to Peru?

As a result of the PTPA, U.S. consumer and industrial goods exports to Peru are no longer subject to tariffs. Peru eliminated tariffs on almost 90% of U.S. agricultural products thus far. The remaining tariffs will be phased out by 2026.

Does Peru have a free trade agreement with other countries?

Peru has signed Free Trade Agreements or Conventions with other countries, which are not members of CAN or ALADI. This Agreement grants preferential tariff treatment to originating goods, which are comprised within the tariff universe according to the corresponding tariff elimination schedule.

However, on August 1, 2020, the Brazilian government eliminated all import tariffs on foreign-manufactured solar photovoltaic equipment, reducing the import tax rate to 0%.
